We invite your child to join the Salt River's Camp S.T.R.E.AM, our 2022 Summer School! This summer program designed to provide your child with academic and STEM activities that will provide enrichment opportunities to them. The program is open to all SRES enrolled students entering grades 1 - 6. Applications will be accepted on a first come, first served basis. Summer school will be in-person and abide by all safety and social distancing guidelines. If the Community's return to work plan determines that we cannot gather, summer school will be virtual.
